

# Pick Six Sports League Privacy Policy

## 1. Introduction

Welcome to the Pick Six Sports Privacy Policy. We are committed to protecting your personal information and ensuring that it is handled in a secure and responsible manner. This policy outlines how we collect, use, disclose, and protect your information.
